

## Community REInvest Sponsorship Agreement

### TERMS & CONDITIONS

1. The rights provided under this agreement to participate in the REIWA "Community REInvest" program are only provided to the business activities conducted by a Corporate Member at the registered office and/or branch office (as those terms are used in sections 36 and 37 of the Real Estate and Business Agents Act, 1978 (Act)), that is named in this form (Office).
2. The Monthly Sponsorship Amount charged of an Office (Monthly Sponsorship Amount) is determined by the Corporate Member nominating the amount in the agreement.
3. Only Supporters registered with REIWA as being associated with the Office may participate in the benefits provided to the Office by this agreement.
4. In the promotion of your sponsorship of "Community REInvest" (Sponsorship) you must only refer to your Sponsorship using words, badges and/or stamps approved from time to time by REIWA and published by REIWA that will be made available to you upon request.
5. Provided that this agreement has not been terminated, for the term of a separate agreement between REIWA and The Salvation Army (Western Australia) Property Trust (TSA) dated 15 October 2013 (TSA Agreement), (a copy of which is available from REIWA upon request), you will (through the Office) be entitled to the benefits of that TSA Agreement provided to REIWA members, including that you (through the Office) will be considered to be a sponsor of the TSA.
6. The Monthly Sponsorship Amount set out on the front page of this agreement, is payable by the Corporate Member monthly in arrears. An adjustment to the Monthly Sponsorship Amount may be made by the Corporate Member, from time to time, upon the provision of one month's prior written notice to REIWA.
7. The Sponsorship is for an ongoing term that will come to an end when either the Corporate Member or REIWA give the other not less than one calendar month's notice in writing that this agreement will be terminated.
8. Upon termination of this agreement the Corporate Member and its Office are no longer authorised to promote the Sponsorship of "Community REInvest" (including, but not limited to, any sponsorship of the TSA) or use any associated words, badges and/or stamps relating to the Sponsorship. The Corporate Member must also return to REIWA, when requested, any material relating to the Sponsorship previously supplied by REIWA.
9. The Office the subject of this agreement will be entitled to the following benefits during the term of this agreement:
  - (a) acknowledgement as a "Community REInvest" sponsor with the Corporate Member's logo on the "Community REInvest" program page on reiwa.com (public and members' websites) and a hyperlink to the Corporate Member's website;
  - (b) acknowledgement as a "Community REInvest" sponsor on the Office's "property" and "AgentFinder" listings on reiwa.com;
  - (c) promotion by REIWA of the "Community REInvest" program in communications (as determined by REIWA from time to time) on the social media channels of REIWA (and the TSA during the term of the TSA Agreement);

  - (e) opportunities to volunteer to participate at activities run by the TSA, as determined by REIWA from time to time (REIWA will provide the Corporate Member with the contact details of its nearest Salvation Army coordinator upon request); and
  - (f) provision of local area marketing material (as determined by REIWA from time to time) for use on the Corporate Member's website or in the Office.
