

## **“2016 REIWA.COM PERTH SCORCHERS PRIZE DRAW” TERMS AND CONDITIONS**

By entering the “2016 reiwa.com Perth Scorchers Prize Draw”, you are agreeing to the following terms and conditions:

### **1. STANDARD TERMS**

- 1.1 The “2016 reiwa.com Perth Scorchers Prize Draw” (the Prize Draw) is a promotion run by The Real Estate Institute of Western Australia (Inc) (ABN 12 908 623 811) (“**REIWA**”) on and subject to these terms and conditions. To the maximum extent permitted by law, REIWA’s decision is final and no correspondence will be entered into in relation to any dispute or other matter arising in relation to the Prize Draw.
- 1.2 Any information about prizes or how to enter the Prize Draw forms part of the terms and conditions of entry.

### **2. WHO CAN ENTER?**

- 2.1 Entry into the Prize Draw is open to members of the public aged between five (5) and fifteen (15). Adults can enter on behalf of their children within the aforementioned age range.
- 2.2 Employees, staff and family of REIWA, Cricket Australia, the Perth Scorchers and Western Australian Cricket Association are not eligible to enter the Prize Draw.
- 2.3 Entrants must live in the Perth Metro region.
- 2.4 The winner must be accompanied and supervised by a responsible adult (over 18 years old).

### **3. HOW TO ENTER**

- 3.1 In order to enter the Prize Draw, entrants must complete the electronic entry form on reiwa.com.
- 3.2 Entrants may only enter the Prize Draw once.
- 3.3 The Prize Draw for the prize “Win a day at the WACA” commences on Monday 7 November 2016 at 12.00pm (WST) and concludes on Monday 16 January 2017 at 12.00am (WST) inclusive (“Prize Draw Period”).
- 3.4 The Prize Draw for the “Double Pass” prizes will commence on Monday 7 November 2016 at 12.00pm (WST) and concludes on Monday 5 December 2016 at 9.00am (WST).

### **4. PRIZES**

- 4.1 The first prize – “Win a day at the WACA” - consists of a day at the WACA for the winner, five friends and their parents (siblings may also attend). The day will be held on 30 January 2017 playing a game of backyard cricket at the WACA with three members of the Perth Scorchers cricket team. Transport to the WACA from a location within the Perth Metro region, food and beverages for the day will be included in the prize. It will be at REIWA’s discretion who is able to attend.

4.2 The second prize - "Double Pass" - consists of two silver tickets to the Big Bash League 06 on either 23 December 2016, 1 January 2017, 5 January 2017 or 14 January 2017

There will be Forty (40) "Double Pass" Prize Draw winners:

- 10 Double Pass winners for the 23 December 2016 match;
- 10 Double Pass winners for the 1 January 2016 match;
- 10 Double Pass winners for the 5 January 2017 match;
- 10 Double Pass winners for the 14 January 2017 match.

4.3 The Double Pass winners are responsible for all other expenses, including all food, beverages and transport to and from the venue.

4.4 Tickets will be posted to winners.

4.5 Should the entrant not be eligible to win the Prize for any reason, the next eligible entrant will win the Prize. This includes not being available on 30 January 2017 for the "Win a day at the WACA".

4.6 The prizes must be taken "as offered" and cannot be varied, extended, transferred or exchanged.

4.8 Any material produced by the Prize Draw will be owned by REIWA.

## **5. HOW TO WIN**

5.1 Entrants must complete the electronic entry form provided on reiwa.com.

5.2 Blank entry forms will be deemed ineligible to enter or win.

5.3 REIWA will subscribe Prize Draw entrants to its reiwa.com e-newsletter. Entrants can opt out from the service by unsubscribing at any time.

5.4 REIWA's decision is final and REIWA will not enter into correspondence regarding the result.

## **6. COMPETITION JUDGING**

6.1 REIWA will draw at random, one (1) individual winner who will win one (1) major prize. The random draw will take place on Monday 16 January 2017 by 5.00pm (WST) at REIWA, 215 Hay Street, Subiaco WA 6008.

6.2 REIWA will draw at random, forty (40) individual winners who will win a double pass. The announcement of the "Double Pass" winners will take place by 5.00pm (WST) on Monday 12 December 2016.

6.3 All winners will be notified by email or telephone and their name and suburb, photograph or logo, as determined by REIWA, may be published on the reiwa.com website and on social media, including Facebook and Twitter.

## **7. NO LIABILITY**

7.1 In the case of the intervention of any outside act, agent or event which prevents or significantly hinders REIWA's ability to proceed with the Prize Draw on the dates and in

the manner described in these terms and conditions, including but not limited to vandalism, power failures, tempests, natural disasters, acts of God, civil unrest, strike, war, act of terrorism, REIWA may in its absolute discretion cancel the Prize Draw and recommence it on the same conditions on different dates subject to any government legislation.

- 7.2 REIWA will not be liable for any misadventure, accident, injury, loss to any property or any personal injury (including but not limited to indirect or consequential loss) or claim that may occur:
- a) during the Prize Draw;
  - b) in the participation or use of any element of the Prize;
  - c) as a consequence of late, lost or misdirected mail or damage to any Prizes;
  - d) due to any publication relating to the Prize Draw or the publication of any material, including any statements made by any competitor, staff member, journalist, other entrants or any other person;
  - e) in relation to failure of an email or mail entry message or electronic means to be received by REIWA on account of technical problems or traffic congestion; or
