IN-HOUSE TRAINING

Delivery of training at premises selected by the agency. All external bookings and costs are the responsibility of the agency including venue hire, catering etc.

A minimum of 10 participants are required.

Mandatory CPD courses

No charge for registered or licensed real estate practitioners - course is fully subsidised by DMIRS.

Elective courses

FULL DAY	20% discount per person for 10 - 44 participants
HALF DAY	20% discount per person for 10 - 44 participants
GROUPS - FULL DAY	\$10,000 (incl. GST)^ For groups of 45 or more a capped price applies
